**Member Agreement - Terms and Conditions**

1. The Member ("you") hereby represent, warrant and covenant that you are a current qualified member in good standing of the CPIA and shall be so at the time of shipment of any package via FedEx pursuant hereto.
2. You agree to be bound by the terms and conditions of the current Program Agreement between Federal Express Canada Ltd. ("FedEx") and Canadian Printing Industries ("CPIA") as if you were the "CPIA" party thereto. The terms and conditions of such Agreement related to Canada-domestic and Canada-export FedEx Express transportation services are incorporated herein by reference. This Member Agreement will be effective for as long as such Program Agreement remains in effect. However, either party may terminate this Member Agreement in its entirety at any time upon thirty (30) days written notice to the other party.
3. The prices and other terms and conditions provided to you as a Member are for your exclusive use and benefit and are to be treated as confidential information. Such prices (or any portion thereof) may not be extended to any other party. You may not under any circumstances sell, assign, or otherwise transfer (including, but not limited to, third party billing) the benefit of this pricing to any non-member of the CPIA. Failure to abide by this provision may result in immediate termination of your participation in the FedEx Program, in FedEx's sole discretion.
4. Each shipment made under this Member Agreement is subject to the terms and conditions of the FedEx Service Guide in effect at the time of shipment, which terms and conditions are incorporated into this Member Agreement by reference. FedEx reserves the right to modify the FedEx Service Guide at any time without notice.
5. Participation in the FedEx Program is conditional upon obtaining FedEx Credit approval. FedEx reserves the right to deny credit and FedEx does not extend consumer credit privileges.
6. Payment on your account is due fifteen (15) days from the invoice date. Duties and taxes are payable on receipt. Failure to comply with FedEx's payment terms may result in denial of credit and removal of discounts.
7. You are prohibited from using the FedEx name or logo without the prior written consent of FedEx.
